#### **Council Direction:**

Council has directed staff to report on the use of Sections 4.10 and 4.11 of the Purchasing Policy on a quarterly basis.

#### Information:

This report is issued quarterly in accordance with the Purchasing Policy. This report details the procurement of goods and/or services during emergency situations and those detailed in Section 4.11 – Negotiations for the second quarter 2011.

The Policy for Negotiations is used in narrowly defined circumstances where it is justified that the policies for the general acquisition process could not be followed. The "Request to Use the Negotiation Policy/Emergency Reporting Form" is completed by the Client Department and signed by the departmental Director or General Manager and is then forwarded to the Procurement Manager for approval. These forms are kept on file in the Procurement Section and are available for viewing by Members of Council upon request to the Procurement Manager. The Procurement Section reviews each request to ensure that fair and ethical practices are utilized when goods/services are acquired using Policies 10 and 11.

During the second quarter of 2011, there were 169 purchase orders issued where Policy 10 and 11 were used, totalling \$5,644,432. The purchase orders are summarized in Appendix 'A' to report FCS11005(a).

#### The breakdown is as follows:

- Nine purchase orders totalling \$318,291 were issued under Policy 10, as "Emergency" purchases, whereby goods and services shall be acquired by the most expedient and economical means. The following purchase order represents the largest dollar amount in this category:
  - O Purchase order 58918 for \$138,289 was issued to Power Station Standby Generator Services. Changes to Provincial Legislation affected the City's ability to receive diesel fuel at all existing water and wastewater pumping stations which currently have stand-by power generators. Plant Operations has applied to Technical Standards and Safety Authority (TSSA) for a Working Variance for 47 of these stations which would permit them to receive fuel on a limited basis, however, 10 stations have been identified as posing an immediate hazard and will require changes before fuel can be received or a Working Variance issued. This Policy 10 was to investigate and repair the diesel fuel systems of 10 of the 47 stations. These repairs will remove any immediate hazards, thus allowing the City to apply for a Working Variance and/or receive fuel. Further scheduled upgrades will have to be undertaken in order to bring all stations into compliance with current legislation.
- Four purchase orders totalling \$182,000 were issued for "Expanded Works".
  When an unexpected problem arose, this extra work did not expand the scope of the project but was necessary in order to deliver the original approved work. The following purchase order represents approximately 55 percent of the total spent for this category:
  - O Purchase order 54550 for \$100,000 was issued to James Kemp Construction Limited for work required to complete contract C14-14-10 General Contractor for Sir Allan MacNab Pool Renovations, after unforeseen site conditions were encountered. These conditions included contamination of the sub base soil, holes and irregular joints concealed with the acoustic insulation, wires and electrical boxes running at the incorrect locations, fire code compliance, waterproofing membrane cleaning, new heat exchanger and fixing insulation in the existing ducts.
- 24 purchase orders totalling \$1,772,737 represents the short-term "Extensions" of current contracts which have expired and unforeseeable circumstances have caused a delay in issuing a new Tender or Proposal document. The following purchase orders represent approximately 59 percent of the total spent for this category:

- Contract C6-06-05 Provision of Vehicle Collision Repair Services As and When Required for City of Hamilton Vehicles was extended to allow time to tender a new contract. \$500,000 was approved to extend the current contract with Lockwood Collision.
- Contract C11-53-02 Leasing Mileage Tires for Transit Buses was extended to December 31, 2011 to allow time to undertake an analysis of 'lease' versus 'buy' solution in the next contract. Purchase order 58333 for \$300,000 was issued to Bridgestone/Firestone Canada Inc.
- Purchase order 57301 for \$243,840 was issued to Kemira Water Solutions Canada Inc to extend Contract C11-55-10 Provision for the Supply and Delivery of Polyaluminum Chloride (PACI) for Coagulation at the City of Hamilton's Woodward Avenue Water Treatment until November 2011. The previous procurement process did not result in an award and this extension will allow time to undertake another procurement process.
- 64 purchase orders totalling \$2,193,556 were identified as "Single Source" purchases whereby a particular vendor was recommended because it was more cost-effective or beneficial to the City. The following purchase orders represent the largest dollar amount in this category:
  - O Purchase order 59394 for \$236,215 was issued to Historic Horizon Inc. to continue providing Stage 2 Archaeological Assessment and limited Stage 4 Archaeological Mitigation consulting services for the Redevelopment of Battlefield Park (East Side). Historic Horizon Inc. has been involved with this project from the onset and it is more cost effective to continue with their service as timing is critical for the mitigation works to be completed prior to the commencement of the stabilization and redevelopment works.
  - Purchase order 54737 for \$193,466 was issued to Newman Bros. Ltd to carry out additional work at Coronation Arena to improve accessibility and energy savings. Newman Bros. Ltd were already on site undertaking work on an existing contract and were able to provide the additional services which ensured the tight completion deadlines were met.
  - Purchase order 58667 for \$101,284 was issued to Glentel Inc. for additional receiver/transmitter equipment to integrate with the existing Hamilton Street Railway Radio System. Glentel Inc. is the only local Motorola Authorized dealer.

- 52 purchase orders totalling \$960,822 were "Sole Source" purchases, where it was deemed that there was only one source of supply in the open market. The following purchase orders represent the largest dollar amount in this category:
  - Purchase order 58547 for \$86,892 was issued to Cansel Survey
     Equipment for two Trimble mobile survey units that will replace two older
     units. The new equipment is required to be compatible with all survey
     crews to utilize and Cansel Survey Equipment is the sole supplier of the
     Trimble equipment.
  - Purchase order 59490 for \$65,662 was issued to Horizon Utilities for 2010 rental charges for City of Hamilton's attachments to Horizon Utilities poles.
- There were 16 instances where departments utilized the Negotiation Policy without receiving the proper approvals as required by the Purchasing Policy. The departments were instructed on the proper procedure to be followed in the future. The value of goods and services procured in these instances was \$217,026.

Requests for Quotations, Tenders and Proposals are issued to encourage the competitive bidding process with objective and equitable treatment of all vendors, in accordance with the Purchasing Policy approved by Council. Council approved Section 4.11 – Negotiations, a policy designed to ensure a fair and equitable treatment of vendors where the competitive process is restricted.
