**CITY OF HAMILTON**

**BY-LAW NO. 12-**

**To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" ( Hamilton) thereof the following items, namely:

"East 26 <sup>th</sup> Street	Crockett Street	Queensdale Ave. E.	40km/h
Ferguson Ave. N	Wilson Street	Kelly Street	40 km/h"

And by adding to Section "F" (Stoney Creek) the following item, namely:

"Lewis Road	Barton Street	Highway 8	40 km/h"

2. Schedule 3 (Flashing School Zones- Reduced Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by removing from Section "F" (Stoney Creek) thereof the following item, namely:

"Highway 8	300m E. of Glover Road	60	8:30 a.m. to 9:15 a.m.
	To 150m. W. of Glover Road		3:30 p.m. to 4:00 p.m."

3. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "G" (Former Regional Roads) thereof the following items, namely:

"West 5 <sup>th</sup> St.	21m N. of Marlowe	West Curb Lane	Anytime	Southerly to Westerly
---------------------------	-------------------	----------------	---------	-----------------------

West 5 <sup>th</sup> St.	Tyrone to 75m South of Marlowe	Centre Lane	Anytime	Southerly to Easterly Northerly to Westerly
Mohawk Rd.	25m E. of Amanda to 35m W. of Athens	Centre Lane	Anytime	Easterly to Northerly Westerly to Southerly”

4. Schedule 10 (No Left Turns) of By-law No. 01-215, as amended, is hereby further amended by adding to Section “E” (Hamilton) thereof the following item, namely:

“Exit from plaza 105m  
S. of Stone Church                      Northerly                      Upper James                      Anytime”

5. Schedule 6 (One- Way Streets) of By-law No. 01-215, as amended, is hereby further amended by deleting from Section “E” (Hamilton) thereof the following item, namely:

“Caroline                      Southerly                      York                      Main”

And by adding to Section “E” (Hamilton) thereof the following item namely:

“Caroline                      Southerly                      York                      King”

6. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
7. This By-law shall come into force and take effect on the date of its passing and enactment.
