### Work of the Arts Funding Task Force to date



#### With Hill Strategies assistance, we have:

- Reviewed the City of Hamilton's current arts funding programs
- 2. Defined the arts community
- Surveyed Hamilton's arts community to determine the funding issues they are facing
- 4. Researched municipal funding models and per capita funding amounts in 7 comparison municipalities
- 5. Analyzed all the data found

### **Funding Snapshot**



Hamilton artists have great difficulty generating earnings from their practice, whether through:

- public funding
- sales
- finding sufficient opportunities or
- marketing their work

Hamilton arts organizations have substantial challenges generating revenues from all three major sources:

- public funding
- earned revenues
- private sector revenues

### **Identified Gaps**



### Gaps identified in City's current approach to arts investment:

- 1. The amount of direct investment in the arts by the City of Hamilton is low compared to other municipalities.
- 2. There is no direct municipal funding for individuals who are involved in artistic creation and presentation.
- 3. There is limited municipal funding or services for business development in the arts sector.
- 4. Current City of Hamilton funding programs for non-profit art organizations do not meet the need for operating and project support and are not seen to be strategic, equitable and transparent.

### Benefits to the City of Hamilton




- Better alignment with Hamilton municipal policies and strategies

- Research objectives
  - Role and structure of arts funding in select Canadian cities
  - Needs of the Hamilton arts and culture community
- Created and conducted online survey
  - HamiltonCulturalSurvey.com (Sept. 6-26, 2011)
  - Responded to questions about key issues, levers, gaps and possibilities regarding the City's cultural services
- 275 responses received
  - Artists ("individuals")
  - Arts organizations or businesses ("organizations")



### Situation of individual artists



- Hamilton artists have very low gross personal incomes
  - Median income ~ \$27,000
- About 30% of income of typical Hamilton professional artist comes from artistic practice
- Median employment income of full-time Hamilton workers ~ \$44,000
- Low-income cutoff for large city: \$22,000 for a single person
  - Over one-third of artists are below this cutoff

### Survey Findings: Individuals
