# **6.1** Occupation Specific Language Training (OSLT) - Mohawk College.

P. Palmer, OSLT - Mohawk College delivered a presentation regarding her program.

The OSLT program provides services to new comers, to improve their workplace communication skills and is funded by Citizenship and Immigration Canada (CIC). In Hamilton, Mohawak College has been offering OSLT program since 2008 and, so far, has offered 8 courses. The OSLT program is offered to the individuals who have educational background or training in Human Services, Health Sciences and Business. The participants of the program normally fall under Canadian Language Benchmark (CLB) 6-8 and must have done a language assessment within last 6 months. The program duration is 6 months, with two lectures per week.

The graduates of the program receive a certificate of participation from Colleges Ontario and Certificate in Workplace Communication Skills for Health Sciences, Human Services or Business.

**Question:** What should new immigrants, having good communication skills, do, since this program is not for them?

A. Such people must get help from Settlement Services.

**Question:** Is this program specific to professionals?

A. The program is specific to the needs of professionals in the area of Early Childhood Education, Child and Youth Work, Nursing, Personal Support Work and Business.

**Question:** How would you compare it with Test Of English as a Foreign Language (TOFEL)?

**A.** The program is not focused on the academic language, i.e. no grammar and writing comprehension. It can not be compared with TOFEL and International English Language Testing System (IELTS).

**Question:** What is the equivalence of this program, as compared to TOFEL/IELTS or CLB?

**A.** None.
