## 4.2 World War I Artillery pieces

Update: Anna spoke to Parks staff regarding locating the artillery pieces at Dieppe Memorial. They expressed concern for vandalism and public safety. Parks staff as well as conservation staff would prefer a less isolated location with some type of enclosure or ideally an indoor location. Committee inquired if there is an empty building in the City where the pieces could be displayed.

At the June meeting Geordie Elms suggested the possibility of including the artillery pieces in a legacy project to mark the 100<sup>th</sup> anniversary of the War in 2014.

At a previous meeting Councillor Morelli mentioned there might be the possibility of something at the renovated Ivor Wynne stadium.

#### 4.9 Fields of Honour

Discussion regarding revised criteria for burial in the Fields of Honour at Woodland Cemetery.

Background / Why the review now?

The understanding is that the Fields of Honour were created for those who wished to have a place to go and remember. Originally based on World War I and II veterans.

Cemetery staff are receiving an increased number of inquiries requesting an expanded eligibility. There are no space issues at this time. The lower field is full but there are between 300 and 400 graves available in upper field. Also, cemetery staff are looking at opening a Field of Honour at Mount Hamilton Cemetery. The issue is strictly criteria.

The committee has an issue with limiting eligibility to campaigns as they feel Afghanistan veterans should be included. Would like to see a criteria that opens eligibility to a wider field. The easiest criteria to administer – persons are eligible for burial in the Field of Honour if they did serve and were honourably discharged or are actively serving, includes regular service and militia.

The majority want it to remain strictly military.

Should spouses be eligible for burial in the Field of Honour if they are not military? The No decision was unanimous.

Hard question – if they are Canadian citizens but served in a non-Commonwealth military should they be eligible for burial in the Field of Honour.

Suggestion – those non-Commonwealth military be buried in an area of the new Field of Honour being considered at Mount Hamilton Cemetery. It is important that these graves be marked in the same respectful manner.

**Action:** Crystabelle will investigate what other municipalities do. She will also contact Veterans Affairs Ottawa to determine if they have any criteria regarding non-Commonwealth military.

To date we do not have any requests for non-Commonwealth military to be buried in the Field of Honour.

Currently there are only 4 or 5 burials in the Fields of Honour each year. The paperwork is forwarded to Carolyn Biggs, Legislative Assistant, Clerks Division, who was secretary for the Veterans committee. Carolyn uses the currently approved criteria to approve or deny the requests.
