# EXECUTIVE SUMMARY

The 2012 Internal Audit work plan approved by Council included an audit of a specific PHS program. The Tobacco Control program was selected for review. Enforcement of compliance with legislative requirements in terms of tobacco promotion, distribution, sale and consumption was examined. The effectiveness and efficiency of the current service delivery model including the administrative procedures were assessed.

The results of the audit are presented in a formal Audit Report (2012-10) containing observations, recommendations and management responses. Audit Report 2012-10 is attached as Appendix "A" to Report AUD13006.

# ANALYSIS / RATIONALE FOR RECOMMENDATION

(include Performance Measurement/Benchmarking Data, if applicable)

There are approximately 465 premises in the City of Hamilton that sell tobacco. Three Tobacco Enforcement Officers (TEOs) visit these premises as well as other institutions

regulated by consumption restrictions to inspect, re-inspect, educate, follow up complaints, and lay charges. Such visits numbered over 1260 (to August 31, 2012) and 1400 in 2011.

The inspection of the premises that sell tobacco is in accordance with the Smoke-Free Ontario Act (SFOA). TEOs' inspections include compliance with promoting the sale of tobacco, storage and warning signs. Inspections are also performed with Test Shoppers aged 15 to 17 years of age to test for the sale of a tobacco product to youth under 19 years. To August 31, 2012 year to date, 96 charges were laid and 42 warnings issued. In all of 2011, charges numbered 177 and there were 103 warnings.

There are provisions in the SFOA which automatically prohibit vendors from selling tobacco products if they are convicted of two tobacco convictions within a five year period.

The results of all inspections are entered in the Tobacco Inspection System (TIS).

A formal Audit Report (2012-10) containing observations, recommendations and resulting management action plans was issued. Five recommendations were included in Audit Report 2012-10 (attached as Appendix "A" of Report AUD13006). The recommendations made are:

- Update PHS's inventory of tobacco vendors to reflect all the premises licensed to sell tobacco products;
- Exchange related tobacco database changes with the Municipal Law Enforcement Section;
- Update Tobacco Inspection System (TIS) to include data from all inspections performed in 2011 and 2012;
- Develop a procedure for use in times of data uploading issues to ensure all inspection information is reported in TIS on a daily basis as specified in the agreement with the Ministry; and
- Request automatic prohibition orders for vendors convicted of two tobacco sales offences within a five year period.

3.	<u>Automatic Prohibitions of Tobacco Vendors</u> Automatic prohibitions are Ministry directives forbidding vendors from selling tobacco products. Such prohibitions are usually the result of a variety of tobacco sales offences, the most common being the selling of tobacco products to youth under 19 years of age. The Smoke-Free Ontario Act (SFOA) Compliance Protocol states that a vendor that has incurred two tobacco convictions within a five year period will face a six month prohibition and three convictions within a five year period results in a nine month prohibition. However, the staff of the Tobacco Control Program only apply for automatic prohibitions of tobacco vendors after they have been convicted three times.
