I had previously filed a petition (#332) concerning federal knowledge of PFOS contamination in Canada.

I have received the responses. I will be scanning the responses into pdf files. If you would like to see the information, please let me know and I will try to send it along ASAP.

Even though the responses contain some new information (at least for the public), many of the key issues/problems were not addressed. I will be following up in order to get this information, and if there are any questions that occur to you please let me know and I may be able to include those concerns as well.

For now, I thought I should send as soon as possible a two lists (one from National Defense, one from Transport Canada) of sites identified as being contaminated with PFOS.

As you can see, these include 7 sites in Ontario and 8 in British Columbia. Please forward these lists to your counterparts in other provinces if you think the information would be helpful to them.
