CITY OF HAMILTON

BY-LAW NO. 12-

**To Amend By-law No. 01-215
Being a By-law To Regulate Traffic**

WHEREAS sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

AND WHEREAS on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

AND WHEREAS it is necessary to amend By-law No. 01-215.

NOW THEREFORE the Council of the City of Hamilton enacts as follows:

1. Schedule 2 (Speed Limits) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "E" (Hamilton) thereof the following items, namely:

"Strathcona Ave. N.	Tom Street	King St. W.	40
Lamoreaux St.	Dundurn St. N.	Strathcona Ave. N.	40"

2. Schedule 13 (Designated Traffic Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "G" (Former Regional Roads) thereof the following items, namely:

"Burlington St.	135m West of Gage Ave.	South	Anytime	Easterly to Southerly
Victoria Ave.	35m South of Barton St.	West	Anytime	Northerly to Westerly
Victoria Ave.	35m South of Barton St.	East	Anytime	Northerly to Easterly

Woodward Ave.	40m North of Brampton St. Centre to 390 North of Glow Ave.	Centre	Anytime	Southerly to Easterly and Northerly to Westerly”

And by deleting from Section “E” (Hamilton) the following item, namely:

“Depew	100ft. north of West Burlington and Burlington		Anytime	Southerly and Southerly to Easterly”

3. Schedule 18 (Bike Lanes) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "G" (Former Regional Roads) thereof the following items, namely:

“Victoria Ave.	Barton St. to Ferrie St.	East Curb Lane	Anytime	Northbound”
Woodward Ave.	Melvin Ave. to Beach Blvd.	East Curb Lane	Anytime	Northbound
Woodward Ave.	Melvin Ave. to Beach Blvd.	West Curb Lane	Anytime	Southbound”

3. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.

4. This By-law shall come into force and take effect on the date of its passing and enactment.
