


Thank you for permitting me to address you today.

Recently, I received two tickets for parking on a "through highway"; (I will refer to "through highways" as a "through streets") both tickets were issued on different streets, neither of which was marked in any fashion indicating they were "through streets". After paying the tickets I decided it was necessary to bring this to the attention of the City as I believe the City is using inconsistent and unjustified practices when issuing these tickets. This results in a gross injustice to the drivers who uses and park on our streets.

What the City is doing could possibly be a legal issue. It is certainly an issue of lack of transparency and lack of evenhandedness on the part of the City. The Cities web-site states that "through streets are those city roadways that display rush hour, snow route signage and/or are main bus routes." This is simply inaccurate as it only applies to some streets meeting one or more of the above conditions. There are lots of streets that meet at least two, possibly three of the above conditions and are not considered "through streets" by the City. Around the corner from where I live is Justine St. which is a "bus and snow route." Justine is not listed as a "through street." More troubling than this, the City has designated quite a few streets as "through Streets that meet NONE of these criteria. (See Appendix A attached).

I am curious what streets that are considered "rush hour" streets have to do with any streets being designated a "through street" as "through street" only applies between 2:00 a.m. and 7:00 a.m. This is not rush hour!

The City does post a sign at major entrances to the City stating that there is to be no parking on "through streets" between 2:00 a.m. and 7:00 a.m. but does not tell you how to determine what are "through streets".





Ms. Pam Carver, the Cities Manager, Parking Enforcement & School Safety referring to By-Law 002-277 paragraph 4 sub section q and By-Law 01-281 paragraph 12 GENERAL PARKING PROHIBITIONS suggested in her response to Councillor Morelli that the City does not sign fire hydrants (warning you to park 10 feet from it) or curbs (telling you to not park more than 12 inches from the curb). interesting and significant distinction. Ms. Carver's is correct. However, Ms. Caver fails to point out that there are no specific fire hydrants or specific curbs which you must comply with these parking regulations. The reason for this omission is obvious – it applies to ALL fire hydrants and ALL curbs in the City of Hamilton as well as any city, town, or village in the Province of Ontario. "Through streets" apply only to a specific group of streets designated by the City of Hamilton. No driver can possibly be expected to remember only specific designated streets even if they did have access to the list of specific streets. If there are any issues with the correct by-law being quoted above might I suggest you contact Ms. Carver for the correct by-law.

As for the matter of this specific list of "through streets", it is important to note that the list is available to a driver only at the City Hall. It is not on the cities web-site, nor is it published at any time in any local newspaper. The cities web-site only states "You may contact our customer service representatives at (905) 540-6000 to determine whether

or not a particular street is considered a through street." This number is only answered during normal business hours (8:30 to 4:30 Monday to Friday). Where is a driver going to get an answer as to what streets are "through streets" at 2:00 a.m.?

This same paragraph states "These prohibitions are in place to ensure that all corrective, scheduled or other road maintenance can be completed". This seems an unlikely rationale for designating a street as a "through street" as the City already uses another solution for this problem. I received my second ticket on Charlton Street, in front of St. Joseph's Hospital. Only one block north of Charlton Street at this point is Forest Ave. It is posted with a sign which states "No parking on the 2<sup>nd</sup> Friday of each month Apr. to Nov." There is yet another sign on Clark Ave. that states "No parking on the 3<sup>rd</sup> Wednesday of each month Apr. to Nov." It has always been my understanding that the purpose of this parking restriction was for the city to "ensure that all corrective, scheduled or other road maintenance can be completed". Why doesn't the City simply sign "through streets" similarly and prepare a proper maintenance schedule. Obviously if the City needs more than a normal amount of time to do maintenance on a particular "through street" this maintenance will either be an emergency or a planned maintenance. In the emergency case, the City will have to deal with this in the same way it would on a normal street. If it is a planned maintenance, then the City will have time to post the street for the specific time required to perform that maintenance.





Please note that from Wentworth St. South at Charlton (going west bound) until the very spot where I received the second ticket there are no signs indicating that Charlton Street is a "Snow route". This street is NOT listed on the list of "through streets" I received from City Hall. (I will address this list later.) Unless it is in the amended By-Laws, I should have never received this ticket in the first place. This first "Snow Route" sign is midway between Hughson St. and James Street. Charlton is not a bus route, but on the meter where I got the ticket is a label indicating this is a "Rush Hour Route where no parking is permitted from 7 AM – 9 AM and 4 PM - 6 PM –Monday to Friday." My ticket was issued on May 23<sup>rd</sup> at 2:34 a.m. It was well outside the hours posted as "Rush Hour" and clearly outside a timeframe that one needed to worry about there being a snow emergency called. There is absolutely no reason for any driver to consider this street at this season of year and time of day as a "through street." None of the qualifying criteria are present at 2:34 a.m. on the date I received my ticket.







In an email to Councillor Morelli Ms. Carver gave the following answer as to why signing may not be appropriate in all cases. "While the present signing method does occasionally result in a complaint from a motorist who is unfamiliar with the regulation, on the whole it has been a satisfactory process in our experience. The signing of every individual Through Street would add to the proliferation of signs throughout the City, and the cost of manufacturing, erecting and maintaining these extra signs would be cost prohibitive".

While preparing this presentation I have observed many parking restriction signs. The sign beside where I was ticketed on Charlton Street stated "No parking from 7:00 a.m. to 9:00 a.m. and no parking from 4:00 p.m. to 6:00 p.m. It was also a metered parking spot giving specific parking time when you must pay. My ticket was issued outside of all these above times. If my reasoning above does not sway you to end the "through street" policy, then why not simply place one more line on the current sign which states No parking from 2:00 a.m. to 7:00 a.m.? Obviously at this time you would encounter the expense of purchasing, preparing and installing new signs but these signs should have been installed in the first place.

Councillor Morelli and Ms. Carver have both mentioned that a driver could have the ticket adjudicated and most times if the reason for the violation is reasonable – say emergency parking at the hospital – it would be forgiven. This does not seem to be the solution. Why should any taxpayer, driver or resident have to go to the trouble and maybe expense of appealing a ticket because the very people he/she pay taxes to, has taken a short cut to satisfy not the taxpayer but themselves. If staff, or the elected officials think that saving taxes for voters is better than being fair to drivers by telling the driver to appeal the ticket, then the staffer or elected official has his/her priorities reversed. Don't hang an innocent person to save the cost of getting it right in the first place!!!!

Recently, I visited City Hall to pick up a copy of the list of "through streets." I was surprised to find that it consisted of 24 single-sided pages broken into various section of the New City of Hamilton. Each section is in alphabetical order, however streets such as Centennial Parkway (and there are many more) are divided into three lines as the sections of "through street" start and end three separate times. What driver will carry this list with them? Provided one does, how is he/she expected to understand the list? More importantly than this list is the fact that it is eleven years old. Many of the "through streets" may no longer be "through street" and to find streets added since 2001, one MUST visit City Hall and search through two very large binder of parking by-laws – not all of them related to "through streets" - to find any additional "through streets".


The above table list Charlton Street as a "through street" was put into place as By-Lay (10.007) I presume this means October 2007. The list I received from the City at City Hall has not been updated since 2001 and does not list this amendment.

It is my strong belief that I have effectively challenged ever plausible argument the City can put forward for having "through streets", or how they designate "through streets", or how they sign "through streets".

Councillor Morelli request that Ms. Carver find out what other jurisdiction do regarding signage. This is a bit upsetting as twice in the past in discussions with the city staff and Councillor Morelli I have referred to what other cities do regarding animal control and green garbage containers only to have both the staff and Councillor Morelli tell me straight out that (paraphrasing) "the City of Hamilton does not need to concern itself about what other cities do. The City of Hamilton makes its own rules!" May I suggest that this answer should apply in this case. Forget what other cities do. In this case they may be making the same error as is the City of Hamilton.

It should also be noted that all the signs posted at the entrance to the City have specific instructions except the "Through Street" sign.





- A You will note the Maximum Speed sign gives a clear instruction "50 km, unless OTHERWISE POSTED." If you don't see a sign then the speed limit is 50 km!
- B The Truck over 4.5 tonnes "must follow THESE SIGNS."
- C The 12 hour parking is clear; the rule applies to "ALL STREETS."
- D However, the "through street" parking gives NO INFORMATION on how to determine what is and what is not a through street OR WHERE TO OBTAIN THIS INFORMATION.

These signs begs the question "Why are there specific instructions given on three of the signs while not on the "through Street" sign"?

This is a matter of fairness. There are NO reasons for the City to hold fast to its current policies regarding "through streets" other than to purposefully have a cash cow ready and willing to milk its residents and visitors. Fairness and transparency are now the only issues. If the City wishes to keep taxes down by unfairly punishing its drivers and visitors the only solution is to continue with its current policy and continue abusing its drivers.

If the City wishes to play fair with its residents it has no other choice than to temporarily end its policy today – this very day - on "through streets" then in consultation with its residents determine if a "through street" policy is any longer desirable.

I offer my cordial participation to any committee that is genuinely interested in dealing with this matter in a fair and transparent manner.

Note; in the summer if there is a need to impose water restrictions the City informs the media and takes out newspaper ads advising its citizens of the water restrictions.

Note; if the City wishes to declare a Snow Emergency it broadcast this on the local radio stations. In the fall the City takes out a one or two page ad in the paper informing the citizens to listen for a possible snow declaration. With this ad the City also informs its citizens of snow clearing regulations (sidewalks and not to shovel onto the street)

It is interesting to note that the City does not automatically fine a violator regarding snow removal or shoveling onto the street. It first visits the offender and gives them a warning. Recently, I received a notice to renew my Dog's license. Every citizen who owns a dog and especially one who has previously licensed their dog know that it needs renewal. Why is the City spending money to remind dog owners to renew their license? I will tell you why; because it is revenue. A number of years ago my neighbour hired an out of town contractor not licensed in Hamilton who caused me considerable problems. I went to the City over it. He was NOT fined, he was told to purchase a city contractors license and he could complete the job. This man violated obvious City by-laws but for some reason the City thought it best to just kindly remind him to purchase a license. By the way he had worked in Hamilton for years and had never purchased a license to do so.

Why would the City give a warning in theses cases, even after well publicizing the by-laws yet feel it has no obligation to give out a warning on unmarked and unpublished "through streets?'

### Appendix A

The streets below represent only a fraction of the street listed on my copy of Schedule 2 which I am told dates back to 2001. I only attempted to look at a few streets as I feel that this small sampling shows clearly that the City is not following its own criteria regarding the designation of "through Streets." Please do not take from my reference to this list that I agree in any way with it being the tool that a resident/driver/tourist should be expected to use in order to determine where not to park. Nor, do I agree with the Cities by-law which requires these people to call a phone number to obtain where they are not permitted to park.

What is interesting with all the streets mentioned in the table below is that all of them have a NO PARKING sign displayed on at least one side of the street; yet the City claims that to do so on streets that meet the criteria for "through streets" would be cost prohibitive.

It would also interest me to know if Council has the authority to step outside their own criteria to designate a street which meets none of the criteria as a "through street as per the Cities own by-law"

As I have visited only a very small fraction of these non-compliant "through streets" I wonder how many of the total list is signed with NO PARKING signs or other signage relating to them being "through streets."

The City may make the argument that the streets listed below all come from areas which were formerly outside the City of Hamilton and only became part of the New City of Hamilton with amalgamation in January 2001. This amalgamation took place more than eleven years ago. This is plenty of time to resolve conflicts regarding parking by-laws which existed between the various municipalities who now form the New City of Hamilton.

To this end, I would very much appreciate knowing what by-laws and what reasons are given to declare the below streets as "through streets;" and of course are they currently "through streets." ????
