# 4.4 Andy MacLaren, Chair, of the Waterdown/Mill Street Heritage Committee

Andy MacLaren, Chair of the Waterdown/Mill Street Heritage Committee addressed the Committee and read from a prepared statement copies of which were distributed and a copy was uploaded onto the City's website and is included in the Clerk's file as part of the official record. Rob Posavad who is a member of the Waterdown/Mill Street Heritage Committee accompanied Andy MacLaren at the podium. Mr. MacLaren proposed that the Abbey Zimmerman House, which is a century stone house built circa 1847 be purchased by Rob Posavad who will restore the house to its original condition. This would require severing the house from the parkland. The complication is that the property is located in the Greenbelt. He displayed photos of the house.

He referred to the website of Michael Bloomberg, Mayor of New York City and his campaign against using Styrofoam for food take-out and indicated that he is in support of this initiative.

He indicated that the Beasley streets are noisy and busy and Cannon Street cuts the neighbourhood in half. He spoke in support of two-way street conversion.
