- (a) That a City of Hamilton Sesquicentennial Initiative to celebrate Canada's 150th Anniversary in 2017 be approved;
- (b) That a Sesquicentennial Advisory Committee be established to assist with the co-ordination of this initiative, together with the staff from the Tourism and Culture Division:
- (c) That the Committee include two (2) members of City Council, one (1) member from the Hamilton Historical Board and one (1) member from the Tourism Advisory Committee;
- (d) That staff be authorized and directed to prepare the Terms of Reference for the Sesquicentennial Advisory Committee for presentation to the General Issues Committee;

EXECUTIVE SUMMARY

As a follow up to the November 28, 2012 meeting of City Council, correspondence from Patricia Saunders Re: Establishment of an Ad Hoc Committee for the Preparation of Canada's Sesquicentennial Celebration, attached as Appendix A to Report PED13110, was referred to the General Manager of Planning and Economic Development for a report to the General Issues Committee.

The City of Hamilton has traditionally celebrated and commemorated significant milestones in Canada's history such as the country's centennial in 1967. Staff is recommending that the City continue this tradition by undertaking a high-level strategy, aligning with any national initiatives, to commemorate Canada's 150th Anniversary in 2017.

HISTORICAL BACKGROUND

Hamilton's Past Commemorative Initiatives

Hamilton has a strong historical connection to participating in important milestones in the history of Canada including the Bicentennial of the War of 1812 (2012 – 2015) as well as Centennial celebrations in 1967. The 150th Anniversary of Canada in 2017 provides a platform for creating legacy projects associated with this important milestone. In 2007, as part of Report PED07257/ECS07069, Council approved the 1812 Bicentennial Commemoration Initiative co-ordinated by the Culture Division and Tourism Division and under the guidance of the Director of Culture and the Director of Tourism. The Report also included a Council approved recommendation for staff to form a Citizens' Advisory Committee who, in partnership with staff, would develop and report back to Council for its approval, a strategy for the City's Sesquicentennial Initiatives.

On March 23, 1963, the Hamilton Centennial Committee met for the first time to begin planning and coordinating the City of Hamilton's observance of Canada's Centennial of Confederation (1967). The Hamilton Centennial Committee recommended that the restoration of Dundurn Castle be designated as a major Centennial project based on prior recommendation of the Board of Control (May 1962). The restored Dundurn Castle opened to the public on June 17, 1967.

Current National Initiative

Government and agencies in Canada are developing plans to mark the 150th Anniversary of Canada in 2017. In March 2010, the Institute of Public Administration of Canada and the firm MASS LBP hosted 150!Canada, a large conference to discuss ways of marking the occasion. As a way of further contributing to the discussions, the House of Commons Standing Committee on Canadian Heritage agreed to undertake a study of Canada's 150th Anniversary. Completed in September 2012, the report titled Canada's 150th Anniversary in 2017, includes extensive consultation with groups and individuals and resulted in a collection of recommendations from the Committee. In the Federal government report, Canada's 150th Anniversary in 2017, a number of agencies were identified as participants in the celebrations including CBC / Radio Canada, the National Film Board (NFB), Library and Archives of Canada (LAC) and various national museums. Other Federal institutions, such as the Parks Canada Agency, the Royal Canadian Mint and the National Capital Commission (NCC), are also interested in participating in the event.

As part of the report's recommendations, the Committee recommends that the Government of Canada make its plans known as soon as possible so that its partners at the provincial, territorial and municipal levels, as well as the private sector, can begin planning. As of April 25, 2013, there has been no further direction or next steps from the Federal or Provincial governments

I am writing to request that you and the city council consider appointing an Ad Hoc Committee to begin planning our sesquicentennial celebration in 2017.

While five years might seem like a long time away let me assure you that much activity is already underway. At the federal level a survey on March 10, 2008 revealed broad public support for Canada celebrating its sesquicentennial. On March 11, 2010 three hundered (300) delegates comprised of public servants, business and community leaders, academics and artists gathered in Ottawa to hear presentations from 27 eminent Canadians. This resulted in a report entitled "150! Canada Conference Report" which outlines their ideas for creating the next great year (2017) in Canadian history. Also at the federal level on September 24, 2012 the report of the Standing Committee of Canadian Heritage entitled "Canada's 150th Anniversary in 2017" was presented to the House of Commons by the Honourable James Moore, Minister of Canadian Culture and Official Languages. The report contains numerous recommendations to encourage Canadians to participate in the celebration of Canada's 150th anniversary with support from the federal government.

Several communities across Canada, some smaller than Hamilton, i.e. Stratford, et al, have already formed Ad Hoc Committees or Task Forces to plan for this significant historical event. Therefore, it would appear that it is not too soon for us to begin.
