# THE TOW TRUCK LICENSING SUB-COMMITTEE PRESENTS REPORT 13-002 TO THE PLANNING COMMITTEE AND RESPECTFULLY RECOMMENDS:

# 1. Tow Truck Licensing Information (PED13095(a)) (City Wide) (Item 6.1)

That the City's By-law to License and Regulate Various Businesses be amended such that the following documents would be accepted by the City as provided by tow operators to the Hamilton Police Service:

- a valid Ontario Ministry of Transportation Safety Certificate;
- a valid Ontario Ministry of Transportation Annual Vehicle Inspection Certificate or a Safety Standards Certificate under the Highway Traffic Act; and
- a Criminal Reference Check.

Where an operator is not under a Hamilton Police Services Tow Contract however, the above exemptions shall not apply and all required documentation must be submitted to the City (no older than 36 days).

## (i) Tow Truck Licensing Information (PED13095(a)) (City Wide) (Item 6.1)

Marty Hazell, Senior Director, Parking and By-law Services, provided an overview of the report with the aid of a PowerPoint presentation. A copy of the presentation has been included in the public record.

- Why is there difficulty tracking offenses under the Anti-Solicitation By-law;
- If Bill 93 is going to be a factor in the City's decision;
- What fees other municipalities charge for initial fees and annual fees:
- What the fines are for charges laid under the by-law;
- How the administration fee structure will impact the licenses and fees:
- Tow truck insurance requirements being added to the by-law;
- By-law enforcement towing costs;

The internal auditor was directed to audit the last 3 years of by-law enforcement towing fees collected.

Staff was directed to investigate the number of potential tow trucks that will seek licenses (Ministry of Transportation - Ontario) and adjust the fees accordingly.
