RECOMMENDATIONS:

- a) That the Hamilton Police Services Board approve the proposed Renewal of a Lease Amendment and Extension Agreement between the City of Hamilton (Tenant) and 2099189 Ontario Ltd. (Landlord), for the purposes of providing a location for the Dundas Community Policing Centre, 2 King Street West, Dundas.
- b) That the Hamilton Police Services Board request that the Mayor and the City Clerk, of the City of Hamilton, execute a Lease Amendment and Extension Agreement, between the City of Hamilton (Tenant) and 2099189 Ontario Ltd., (Landlord), for the purposes of providing a location for the Dundas Community Policing Centre, 2 King Street West, Dundas.
- c) That the Lease Agreement for 2 King Street West, Dundas, contains the following terms and conditions:

Area:

Approximately 1,054 square feet of ground level space.

Term:

A period commencing on December 1, 2013, and expiring November 30, 2018. The lease may be terminated by the Lessee at

any time with no penalty by providing six-months' notice.

Rental Rate:

\$16,864.00 per annum plus H.S.T. The payments will be made

from Account #376614-55358.

FINANCIAL / STAFFING / LEGAL IMPLICATIONS:

FINANCIAL — The 5-year lease for the Dundas Station expires November 30, 2013. The lease payments each and every year are \$16,864.00 per annum or \$1,405.33 per month. This rental rate of \$16.00 per square foot (an increase of \$1.00 per square foot) has been negotiated by Police staff based on the available space in the Dundas area. Police staff was supported during negotiations by the City of Hamilton Real Estate Division and this recommendation is based on the criteria of cost and availability.

Funding for the lease is identified in Facilities Account #376614-55358.

STAFFING - n/a

LEGAL -

That the Chair and Administrator of the Police Services Board, under the direction of Legal Counsel, will be required to execute an agreement for the 5-year extension of the existing lease agreement, for the Community Policing Centre. The proposed lease document has a provision for cancellation of the lease at anytime with six (6) months' notice.

BACKGROUND:

The Police Service is committed to maintaining a permanent visible presence in the community of Dundas. The Dundas Policing Centre has been located in the present site for the past 20 years and has become a recognized presence on the main street of Dundas.

This agreement continues to have a lease cancellation clause, with no penalty, provided six (6) months' notice is provided. The reason for this is to allow flexibility in adjusting facility needs, should this be necessary, due to continued increased growth in the eastern part of Division 3 (Ancaster, Dundas, Waterdown and Flamborough). No changes are anticipated in the current service delivery model at this time.

The negotiated price increase of approximately \$1.00 per square foot, is recommended as a reasonable increase over the last five (5) years.
