**CITY OF HAMILTON**

**BY-LAW NO. 13-**

**To Amend By-law No. 01-215  
Being a By-law To Regulate Traffic**

**WHEREAS** sections 8, 9 and 10 of the Municipal Act, 2001, S.O. 2001, c. 25, authorize the City of Hamilton to pass by-laws as necessary or desirable for the public and municipal purposes, and in particular paragraphs 4 through 8 of subsection 10(2) authorize by-laws respecting: assets of the municipality, the economic, social and environmental well-being of the municipality; health, safety and well-being of persons; the provision of any service or thing that it considers necessary or desirable for the public; and the protection of persons and property;

**AND WHEREAS** on the 18th day of September, 2001, the Council of the City of Hamilton enacted By-law No. 01-215 to regulate traffic;

**AND WHEREAS** it is necessary to amend By-law No. 01-215.

**NOW THEREFORE** the Council of the City of Hamilton enacts as follows:

1. Schedule 4 (Yield Control) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "A" (Ancaster) thereof the following item, namely:

"Pine St. and Evergreen Ave.	Southbound	Evergreen Ave."

And by deleting from Section "A" (Ancaster) thereof the following items, namely:

2. Schedule 5 (Stop Control) of By-law No. 01-215, as amended, is hereby further amended by adding to Section "A" (Ancaster) thereof the following items, namely:

Elm Hill Blvd.	Eastbound/Westbound	Lynda Ln.
Elm Hill Blvd.	Westbound	Hostein Dr.
Hatton Dr.	Northbound	Calvin St.
Hostein Dr.	Northbound/Southbound	Elm Hill Blvd.
Lynda Ln.	Northbound	Elm Hill Blvd."

And by adding to Section "D" (Glanbrook) thereof the following items, namely:

"Cook St.	Northbound	Yager Dr.
Dunvegan Pl.	Northbound	Mother's St.
Dunvegan Pl.	Southbound	Greti Dr.
Gowland Dr.	Eastbound/Westbound	Binhaven Blvd.
Greti Dr.	Northbound	Mother's St.
Tinlin Dr.	Westbound	Binhaven Blvd.
Turi Dr.	Northbound	Mother's St.
Turi Dr.	Eastbound	Greti Dr.
Whitwell Way	Eastbound/Westbound	Binhaven Blvd."

And by removing from Section "D" (Glanbrook) thereof the following item, namely:

"Gowland Drive	Westbound	Binhaven Boulevard"

And by adding to Section "E" (Hamilton) thereof the following items, namely:

"Briarwood Cres. (West leg)	Northbound/Southbound	Bendamere Ave.

And by adding to Section “G” (Former Regional Roads) thereof the following item, namely:

And by removing from Section “F” (Stoney Creek) thereof the following item, namely:

“McNeilly Rd.	Eastbound/Westbound	Barton St.”

3. Subject to the amendments made in this By-law, in all other respects, By-law No. 01-215, including all Schedules thereto, as amended, is hereby confirmed unchanged.
4. This By-law shall come into force and take effect on the date of its passing and enactment.
