#### RECOMMENDATION

- (a) That the Hamilton Cycling Committee 2014 base budget submission, in the amount of nine thousand dollars (\$9,000), as described in Appendix "A" to report PW13091, be approved and forwarded to the 2014 budget process (GIC);
- (b) That in addition to the base funding, that a one-time budget allocation for 2014 of one thousand dollars (\$1,000), funded by the Hamilton Cycling Committee reserve, be approved and forwarded to the 2014 budget process (GIC).

#### **EXECUTIVE SUMMARY**

The Hamilton Cycling Committee has developed a request for funding, for planned activities in 2014. With the endorsement of the Cycling Committee, this request for funding was forwarded to Public Works staff as Appendix "A". This report presents this proposed budget to Public Works Committee for consideration as part of the 2014 budget process.

The Hamilton Cycling Committee is proposing a 2014 budget of ten thousand dollars (\$10,000). Their approved budget in 2013 was also ten thousand dollars (\$10,000). In 2013 they were able to draw two thousand dollars (\$2,000) from the Cycling Committees reserve, but in 2014, the reserve is projected to only provide one thousand dollars (\$1,000) in funding. The Cycling Committee is therefore requesting that the

subsidy from the levy be increased by one thousand dollars (\$1,000) to nine thousand dollars (\$9,000).

#### FINANCIAL / STAFFING / LEGAL IMPLICATIONS

**Financial:** For 2014, the Hamilton Cycling Committee (HCyC) has requested a budget of ten thousand dollars (\$10,000), which includes a nine thousand dollar (\$9,000) subsidy plus one thousand dollars (\$1,000) from reserve. The projected HCyC reserve account balance by the end of 2013 is eleven hundred dollars (\$1,100). The proposed budget will finance community educational activities plus the production of safety and promotional materials. The HCyC has been operating with an annual budget of ten thousand dollars (\$10,000) or more for the past three years and has been relying on the reserve account to maintain this level of funding. Since the reserve account has an appropriately modest balance, the HCyC requests that financial support reflect this current level of activity.

A comparison of the budgeted projects for 2014 versus 2013 reveals that the HCyC has a similar work plan for 2014.

The HCyC received a five hundred dollar (\$500) grant from the Ministry of Transportation to expand their safety campaign in 2013 and intend to apply for this grant again in 2014.

#### HISTORICAL BACKGROUND

The Hamilton Cycling Committee (HCyC) advises the City of Hamilton on all matters related to cycling - monitoring the implementation of the Hamilton Cycling Master Plan (Shifting Gears 2009), planning for bicycling facilities (e.g. bike parking), educating citizens on matters of traffic safety, and promoting cycling both for recreation and commuting. Cycling helps to maintain personal health, thus it helps to foster a healthier community. In 2013 over forty thousand (40,000) bike maps were distributed and approximately thirteen kilometres (13km) of bike lanes were installed in Hamilton. The HCyC provided valuable input into these bike lane projects. The HCyC's activities also help to achieve the objectives of the Transportation Master Plan.

#### POLICY IMPLICATIONS/LEGISLATED REQUIREMENTS

This report strongly aligns with the City's Vision Statement, the City's Mission Statement, and the City's Priorities in the Strategic Plan; as these statements make reference to engaged citizens, children, health, safety, and sustainability. The City's Transportation Master Plan and Cycling Master Plan both advance a well connected cycling network, promotion, and safety education that are supported by an engaged Hamilton Cycling Committee.

#### **RELEVANT CONSULTATION**

In preparation of this report, Public Works staff consulted the Hamilton Cycling Committee and Corporate Services Finance and Administration staff.

#### **ANALYSIS / RATIONALE FOR RECOMMENDATION**

Feedback received by members of the Hamilton Cycling Committee (HCyC) ensures cycling projects are well vetted by the community, thereby improving the quality of cycling facilities - both for recreation and commuting.

The committee promotes cycling safety through their very successful "Share the Road" campaign which includes the popular car magnets and stickers, ads on the HSR fleet, and the installation of a banner over Main Street in downtown Hamilton and over King Street in Dundas. This campaign is planned to continue in 2014.

Committee members promote cycling in Hamilton during events like "Bike-to-Work Day", "OpenStreets Hamilton", and City festivals. The committee members also serve as volunteer staff for the HCyC booth at the Toronto International Bike Show, promoting Hamilton as a cycling destination and receiving feedback from people that cycle on

Hamilton facilities – including Hamilton residents attending the show. The committee works with Tourism Hamilton to promote the city's recreational assets through the pamphlet "Cycling Hamilton - Waterfalls & Vistas".

#### **ALTERNATIVES FOR CONSIDERATION**

#### Alternative 1 - City Chooses to Modify the Proposed Budget

The Public Works Committee could choose to modify the funding level of this Volunteer Committee of Council. If the Hamilton Cycling Committee's 2014 budget request is not approved, they would have to adjust their proposed 2014 work plan to accommodate the approved funding level. The members feel that their planned budget for 2014 reflects a commitment to improving safety in Hamilton, promoting cycling as an economic engine in tourism, and fostering a healthier community.
