3.1 Ontario Disaster and Relief Assistance Program (ODRAP) – December 22, 2013 Ice Storm

## (Merulla/Partridge)

That Item 3.1 respecting Disaster Relief Financial Assistance – December 22, 2013 Storm Event be deleted in its entirety and replaced with the following in lieu thereof:

#### Disaster Relief Financial Assistance – December 22, 2013 Ice Storm Event

WHEREAS, the City of Hamilton recently experienced an ice storm disaster event on December 22, 2013 that lasted a number of days in which areas of the City experienced significant property and infrastructure damage, due to heavy volumes of ice and freezing rain;

AND WHEREAS, large Ontario municipalities typically are not successful at receiving disaster financial assistance under the Ontario Disaster Relief Program (ODRAP);

AND WHEREAS, the City of Hamilton has ceased to receive the primary transfer payment from the Provincial government (OMPF) since 2011;

AND WHEREAS, the Honourable Premier Wynne has said to municipalities that the Provincial government is "looking into where there might be the possibility to get some compensation";

THEREFORE BE IT RESOLVED:

- (a) That the Council of the City of Hamilton hereby requests the Minister of Municipal Affairs and Housing declare all areas in the City of Hamilton, which were affected by such disaster, a "disaster area" for the purposes of the Ontario Disaster Relief Assistance Program (ODRAP).
- (b) That the City of Hamilton request that the Province of Ontario provide financial assistance to the City of Hamilton and Horizon Utilities for costs incurred as a result of the December 22, 2013 Ice Storm Event.
- (c) That a copy of this resolution be circulated to all local MPP's and MP's. **AMENDMENT CARRIED**
