I would like to see several improvements and changes to our city. This form letter fill out will have a point form issue and I can present the full details for each point later. 1. All way stop sign at Gladstone and Deleware moved to Sandford and Deleware and returning Gladstone to north-south stop only. While doing so please paint crosswalks, break lines. 3. Garbage cans placed at the entrances of the Lifesaver's Park and the park at Myrtle and Deleware, 3. Street sweeping to be done the day after garbage collection not the night before it is picked up. A simple fix is as easy as rolling the entire schedule 24-36 hours forward. 4. Garbage collectors to stop throwing out cans into their trucks without notifying the home that the have done so. Why should the home owner have to replace their property at their expense because of lazy or bitter staff? I have had mine destroyed 3 times now. Each time your phone call takers at the city number have basically told me to go get my own replacements at my cost and effort, 5, Two way streets converted from one way streets still do not have a bus route going the other way. For example there is no north bound bus on John and no south bound bus on James. 6. A mandatory turning lane put in at Cumberland and Wentworth near the train tracks designating one lane as a turn to the east for Cumberland and a lane heading towards the escarpment for those waiting for trains to pass. 7. Stiffer penalties for dog owners who throw poop bags. 8. Changing the border of several wards to clearly define who has the Wentworth Stairs in their area. It is badly neglected and several people may be responsible. Add garbage cans and fix lights as a minimum. 9. Forms from the city fixed. I had lead pipes removed from 273 Stinson Cress, (grandmothers former home). According to the form I got to have the water turned back on I was told I could call until 5. I called at 440 according to what I could do by your letter...and had to be put through to emergency services. Well, the city closes at 430. Please coordinate your departments with city standards, 10. New Downtown Bus Terminal clock (MacNab and Main, near Hamilton Place and Family Court House) needs to be corrected regularly to the proper time. 11. 2am time for parking on "through streets" near bars needs to be moved to 3am to prevent bar staff and patrons from being ticked before they can get off work or exit the establishment at last call. 12, No Smoking at kid play areas in city parks. Install an emergency call box in those play areas. For example put a radius around the splash pad and climbers at Gage Park where smoking is prohibited. 13. Emergency exits to streets along Cumberland from the Bruce Trail System. Currently, the city has fenced off the escarpment from Gage to Wentworth. How do people get out of there is an emergency? 14. HSR - Extend all bus hours to 220am (add one hour Monday through Saturday) to allow bar staff and drunk patrons an option of getting home other then the expensive taxl or driving drunk if they cannot get a designated driver. 15. HSR - Change Deleware,

King, Barton and Upper James bus routes to 24 hours. Hamilton is potentially the 9th biggest city in Canada. I think we should recognize that we don't really shut down. 16. HSR - add B-line stop at Gage and Wellington. 17. HSR - Eliminate charge for presto pass. Why do people have to pay for a card now? You don't have to pay for a ticket or pass... the city gets the money to invest right away without middle retailers. 18. Removal of the "zero tolerance" to violence around city staff or modify it to not have them have the power to criminally charge people who loudly disagree with them... and make it so the staff of the city of Hamilton (including bus drivers) accountable on the same standards, 19.
