My name is Manny Bastos, I am with LIUNA Local 837, as the Business Manager.

We are proud of being LIUNA, our membership, our skills and our community involvement.

LIUNA operates two banquet facilities (LIUNA Gardens and LIUNA Station) in Hamilton, 256 nursing home beds, non-profit rental units, redeveloped the Lister Block, sizable real estate portfolio and a training centre that is second to none. The 7 Local 837 officers are very involved in their respective communities. All of this adds to the quality of life to the city of Hamilton and its residents.

Our 4,000 members represent some 10 to 12,000 families in the Hamilton/Niagara area. All tax paying community minded citizens. Our members are highly skilled and produce value for their work.
