Lisa Nussey and Rachel More attended the meeting to present an overview about the mandate and activities of the Hamilton Friendship Association with Cuba. The Association was founded on May 26, 2007, with a mandate to further strengthen the ties of friendship between the peoples of Canada and Cuba. The Association charges a \$20 membership fee per year, which may be waived due to financial difficulties. As part of its initiatives, the Association in collaboration with Bryan Prince Bookseller, is organizing an event titled "Rhythm of Resistance", on February 23, 2013 at 6:30 p.m., to celebrate Black History Month, as well as a fundraiser for the Cuba Hurricane Relief fund. Committee members were encouraged to attend the event.

The Committee agreed to host the event on March 1<sup>st</sup> and 2<sup>nd</sup>, so they could have more time to plan.
