## 10.1. Report - J. Rhodes.

J. Rhodes shared a news article regarding Mr. Giddeon McGuire Augier who has been accused of impersonating and providing, at cost, legal services, out of the Abba Uno Centre, in Hamilton, primarily targeting new immigrants and refugees. According to the article, Augier is not a lawyer and does not have legal training and the Ontario Supreme Court of Justice issued a permanent injunction against Augier to practice law and to provide legal services.

The Committee will refer the article to the Immigrant and Refugee Advisory Committee since it is primarily new immigrants that are allegedly being targeted by this individual.

That the case of Giddeon McGuire Augier be referred to the Immigrant and Refugee Advisory Committee and that the Immigrant and Refugee Advisory Committee provide a progress report to the Committee Against Racism, concerning any actions it has taken on this case.
