# THE PUBLIC WORKS COMMITTEE PRESENTS REPORT 11-007 AND RESPECTFULLY RECOMMENDS:

## 1. Temporary Closure of King Street (South Side) from James Street to Hughson Street for Public Works - Transportation Demand Management Activities (PW11040) (Ward 2) (Item 8.1)

That the ad-hoc temporary closure of King Street (South Side) from James St. to Hughson St. for summer events starting on June 1<sup>st</sup> and ending September 30<sup>th</sup>, which include four anchor events organized by Public Works - Transportation Demand Management, be approved subject to the following conditions:

- (a) That the prior approval of the Chief of Police or his designate be received, and that such permits or authorizations as may be required by the Chief of Police or his designate be obtained;
- (b) That all detour signing and warning boards be installed in advance by the Public Works Department, on the affected roadways, if deemed necessary by the General Manager of Public Works;
- (c) That all barricading be subject to the approval of the General Manager of Public Works or designate;
- (d) That the applicant ensures that clean up operations are carried out immediately before the re-opening of the road;
- (e) That no property owner or resident within the closure be denied access to their property upon request;
- (f) That all property owners and tenants within the closure area be notified by the applicant, prior to the closure, in a form acceptable to the General Manager of Public Works.

#### 2. Mohawk College Transit Hub (PW11036) (Ward 8) (Item 8.2)

- (a) That the General Manager of Public Works be authorized and directed to negotiate any and all contracts, agreements, forms, applications or other documents (collectively "Agreements") as may be required with respect to the provision of Metrolinx Quick-Win funds for, the construction of, and the City's use of, a new mixed-use/multi-modal transit facility and related transit amenities on Mohawk College of Applied Arts and Technology ("Mohawk College") campus;
- (b) That the General Manager of Public Works be authorized and directed to execute all negotiated Agreements as described in (a) above, in a form acceptable to the City Solicitor and City Clerk.

# 3. West Harbour Property Demolition Funding and Interim Use (PW11039) (Ward 2) (Item 8.3)

That funding up to \$775,000 for the cost of demolition and any additional expenses of the buildings identified in Report PW11039, be charged to the Unallocated Capital Reserve 108020.

Chair Powers announced that Hamilton City Hall had won two awards at the Building Owners and Managers Association of the Greater Toronto and surrounding area (BOMA), annual awards event on April 27<sup>th</sup>. Hamilton City Hall was awarded the "Certificate of Building & Management Excellence", that recognizes quality in buildings and their management teams and the prestigious "2011 Office Building of the Year" (corporate facility category).

The City of Hamilton has now been nominated for the national "Outstanding Building of the Year Awards". This national conference and exhibition is being held in St. John's Newfoundland and Labrador in September at which time Hamilton City Hall will compete for corporate facility of the year.

#### (f) PUBLIC HEARING/DELEGATIONS

#### (i) Delegation by Daniel Sinha, respecting the stop sign at Linington Trail and Newcombe Road (Dundas) (Item 6.1)

Mr. Sinha addressed the Committee with the aid of a Power Point presentation. Highlights included but were not limited to the following:

- Discussed the area of Linington Trail and Newcombe Road
- Discussed the reasons he was given that a stop sign was installed, such as concerns from area residents about speeding
- Said that the City of Hamilton Traffic Department has indicated to him that stop signs are not used to address speeding
- Showed videos of cars rolling through the intersection
- Indicated that there is a hill before the intersection which creates problems with stopping and starting in the winter
- Indicated that in his opinion this stop sign is a hazard because vehicles do not stop
- Suggested removing the stop sign and increasing police enforcement and/or doing a neighbourhood speed watch program

Committee members asked several questions. Highlights included but were not limited to the following:

- Councillor McHattie thanked Mr. Sinha for his delegation and commented that he believes this is part of a larger issue that needs to be addressed with traffic policy. Councillor McHattie indicated that currently the stringent requirements for traffic calming measures give Councillors few options to address the concerns of citizens.
- Councillor Merulla indicated that there was a previous attempt to lobby the Province on pedestrian protection issues and he would like to pursue this.
- Councillor Duvall asked about the survey and the 86% approval rating of residents for the stop sign
- Mr. Sinha indicated that the survey listed non-responses as approving of the stop sign which he feels is misleading
- Chair Powers verified that of those that did respond there was a 63% approval of the installation of the stop sign

- Mr. Sinha commented that he believes this stop sign has been shown to be dangerous and this should trump all surveys as safety is the primary issue
- Councillor Whitehead asked if there were any instances of accidents at this stop sign location since it was installed
- Mr. Sinha indicated that there was an issue with tire tracks going over the curb in the winter.

On a Motion staff were directed to report back to the Public Works Committee respecting the stop sign at Linington Trail and Newcombe Road.

On a Motion staff were directed to provide an update on the efforts by the City of Hamilton to lobby the Province on the pedestrian right of way.

The Delegation by Daniel Sinha, respecting the stop sign at Linington Trail and Newcombe Road, was received.

# 10.1 Review of Traffic Policies in relation to promotion of pedestrian issues

Whereas in efforts to ensure safer neighbourhoods for children, seniors, and families, City Councillors continue to install stop signs and pedestrian–activated traffic crossings that are considered "unwarranted" by city staff, and;

Whereas the city-wide Transportation Master Plan, neighbourhood transportation Master plans, and the Walkability Master Plan (in preparation) are in unintended conflict through not adequately addressing vehicular volumes and speeding while promoting walking.

That a review of the Traffic Policies (including, traffic calming measures and pedestrian activated lights) be undertaken as part of the Walkability Master Plan process.
