3. 2024 Frostbites Festival - Celebrating Community-Building in Ward 3 (Added Item 11.1)

(Nann/M. Wilson)

WHEREAS, Frost Bites, now in its 8th year, Frost Bites returns to Bernie Morelli Recreation Centre in Ward 3 as a one-week community-embedded festival inspiring residents to engage in free public events that build connections and celebrate community-building in Ward 3 and across the city while activating public spaces;

WHEREAS, Frost Bites is exemplary of winter community programming for all ages that radically reimagines a performing arts festival with a grass-roots creation approach, while showcasing live Indigenous music, participatory storytelling sessions in English & French, indoor and outdoor activities,

WHEREAS, Frost Bites has a history of activating and illuminating community spaces in Ward 3 along Barton St through a unique lineup of performances and activities, including at the Westinghouse, 541 Café & Eatery, and at the Cotton Factory, and will once again use the Bernie Morelli Recreation Centre as the festival hub in 2024 for all residents to enjoy;

WHEREAS, Frost Bites has connected and formed partnerships with a diversity of community organizations in Ward 3, including the Afro-Caribbean Canadian Association, Hamilton Aerial Group, L'Arche, the Immigrant Working Centre, Centre Francophone, Indigenous consultants, and Keeping Six to ensure that programming is developed by and for the community, while also informing the community;

WHEREAS, the Frost Bites festival is organized in part by Ward 3 residents, features artists and performers from Ward 3, and will provide resiliency to the local community in a recovery framework by building community connections, supporting arts, developing skill sets and highlighting a facility with a variety of beneficial programming; and

WHEREAS, the Ward 3 Non-Property Tax Revenue Account is at the discretion of the Ward 3 Councillor's Office and has been used to empower resident-led initiatives that benefit the local community and harness resilience and belonging in Ward 3.

THEREFORE BE IT RESOLVED:

- (a) That \$2500 be allocated from the Ward 3 Non-Property Tax Revenue Account 3301609603 to the Hamilton Festival Theatre Company as the fiscal sponsor for the Frost Bites Festival; and

(ii) Development of a Policy for the Use of Indigenous Images and Themes in City of Hamilton Facilities (Added Item 12.2)

WHEREAS, the City of Hamilton is situated on the traditional territory of the Erie, Neutral, Huron-Wendat, Haudenosaunee and Mississaugas, and that this land is covered by the Dish With One Spoon Wampum Belt Covenant, which was an agreement between the Haudenosaunee and Anishinaabe to share and care for the resources around the Great Lakes, and that this land is covered by the Between the Lakes Purchase, 1792, between the Crown and the Mississaugas of the Credit First Nation;

WHEREAS, the City of Hamilton is home to many Indigenous people from across Turtle Island (North America) and we must do more to learn about the rich history of this land so that we can better understand our roles as residents, neighbours, partners and caretakers;

WHEREAS, the City of Hamilton is committed to having a trusting relationship with Indigenous communities where we communicate and work together appropriately to address the unique needs and issues of Indigenous people;

WHEREAS, the City of Hamilton's Urban Indigenous Strategy identified the need to do more to visually represent the historic and continuing presence of Indigenous peoples and recognized that Indigenous cultures and traditions need to be respected and seen as more than a performance;

WHEREAS, in accordance with the Hamilton Urban Indigenous Strategy, Indigenous people, inclusive of First Nations, Métis, and Inuit, must be involved in decision-making in municipal activities that affect them, and that consultation with urban Indigenous people and communities must be meaningful;

WHEREAS, on April 15, 2019, the Mayor of the City of Hamilton received correspondence from the Ontario Human Rights Commission through Chief Commissioner Renu Mandhane regarding a settlement reached in an Application before the Human Rights Tribunal of Ontario involving the City of Mississauga, and as a result of the settlement, the Ontario Human Rights Commission wrote to all Ontario municipalities to encourage them to collaborate with local Indigenous communities to develop a policy on the use of Indigenous themed logos and names within their sports facilities; and

WHEREAS, City Council approved the Use of Indigenous Images/Themes in City Sports & Recreation Facilities Policy on January 24, 2024, but that a similar policy does not exist for all indoor and outdoor facilities under the jurisdiction of the City of Hamilton.

THEREFORE, BE IT RESOLVED:

- (a) That staff be directed to report back to the Emergency and Community Services Committee by the end of Q2 2024, with a culturally appropriate policy for the use of Indigenous images and themes in indoor and outdoor facilities under the jurisdiction of the City of Hamilton;

EXECUTIVE SUMMARY

In June 2021, the Emergency and Community Services Committee approved Hamilton's Community Safety and Well-Being Plan (HSC19032(a)). The plan aims to ensure all residents in the community feel safe, have a sense of belonging and can meet their needs for education, healthcare, food, housing, income, and social and cultural expression. In Hamilton, priorities include hate incidents, violence, mental health and stigmatization, substance use, homelessness and access to affordable housing and income.

In November 2022, a community consultation was held bringing together more than 110 participants, representing a wide range of sectors and organizations to learn more about Community Safety and Well-Being and provide an opportunity to inform what initiatives should be included in the 2023 Community Safety and Well-Being Implementation Plan. Of six key recommendations, the most prevalent suggestion from the community was the development of a Situation Table with a focus on supporting children and youth.

Situation tables are a forum that involves decision-makers from several organizations including health, social service, and public safety sectors to convene regularly and leverage community assets and relationships to rapidly connect clients living with acutely elevated risk to a holistic group of protective services to prevent a crisis and help clients to better manage and reduce the risk factors in their lives. Situation tables can have a variety of focus areas depending on the needs of a community.

To move forward, a Collaboration and Information Sharing Agreement is being developed in consultation with the City Solicitor to outline the roles and responsibilities of the parties involved and the required measures of accountability. Core participants of the Situation Table will be consulted in development of the agreement and each organization that participates as a core member of the table will be required to enter into the agreement. Additionally, the Ministry of the Solicitor General provides municipalities with access to a Risk-driven Tracking Database as a standardized means of gathering information without direct identifiers on situations of elevated risk for communities implementing multi-sectoral risk intervention models, such as a situation table. Upon approval, the City will enter into an agreement to collect data at the Situation Table through the Risk-driven Tracking Database.

The development of a Situation Table in Hamilton provides an opportunity for multisectoral organizations to come together to implement an upstream risk intervention and prevention initiative that will provide wraparound supports to children and families with the goal of improving their overall safety and well-being.

HISTORICAL BACKGROUND

In 2019, the Emergency and Community Services Committee was notified of new legislative requirements for municipalities to prepare and adopt a Community Safety and Well-Being Plan (HSC19032). In June 2021, the Emergency and Community Services Committee approved Hamilton's Community Safety and Well-Being Plan (HSC19032(a)). This plan outlines a framework for collaborating with partners to promote the safety and well-being of all residents. The content within the plan was informed through data and evidence related to local risk factors and trends, as well as consultation with Hamilton residents, service providers and advisory committee members. The local priorities include hate incidents, violence, mental health and stigmatization, substance use, homelessness and access to affordable housing and income.

Hamilton's Community Safety and Well-Being Plan is overseen by an advisory committee, referred to as the System Leadership Table, which meets both legislative requirements and brings together various sectors' perspectives to provide strategic advice and direction to the City of Hamilton on the plan. The committee brings together partners from the health, social service, and public safety sectors.

A Situation Table Working Group comprised of partners from across various social service, health and public safety sectors was established in April 2023 to develop a model for Hamilton (Appendix A). Several components were consulted to inform the model for Hamilton including:

- Ministry of the Solicitor Generals' guidance document on Information Sharing in Multi-Sectoral Risk Intervention Models²
- Data from the Situation Table Working Group; and,
- Scan of existing local tables to ensure no duplication of mandates for the situation table.

Drawing on these important elements and in collaboration with community partners, a conceptual model has been developed. The focus area of the table for the pilot phase will include youth 8 to 14 years of age with acutely elevated risk and their families.

The "acutely elevated" nature of risk situations means that:

- Chronic conditions (like poverty, addictions and negative parenting) have accumulated to the point where a crisis is imminent.
- New circumstances have contributed to significantly increase chances of severe harm or victimization; and/or,
- The effort to mitigate risk and thus avoid harms exceeds the capacities of any one agency or even two agencies acting in partnership.

It is expected that the risk situations accessing the Situation Table will entail two or more risk factors and benefit from multiple human services organizations working together to improve outcomes.

Membership of the Situation Table will consist of representatives from a variety of sectors including health, social service, and the public safety sector and the Collaboration and Information Sharing agreement(s) that they will be required to enter into will be structured to allow membership to change as needed.

To support the operations of the Situation Table, the Risk-driven Tracking Database managed by the Ministry of the Solicitor General's Office will be utilized. The Risk-driven Tracking Database is a tool that helps communities collect information on local priorities such as agency and sector engagement, risks, vulnerable groups, protective factors and service availability and mobilization. A Risk-driven Tracking Database Agreement must be entered with His Majesty the King as represented by the Solicitor General before the City can access the database. Training and resources are provided for all new users of the database. The Ministry has implemented privacy and security measures to protect the information stored in the database.

The Situation Table will be a pilot that will run for 12 months from its inception. An evaluation will be completed, and recommendations will be made to determine if the

Situation Table will continue to operate and/or if there are opportunities to develop additional tables to support other focus areas within the community. The anticipated timeline for implementation of the Situation Table is Q3 2024.

POLICY IMPLICATIONS AND LEGISLATED REQUIREMENTS

All required policy and legislative requirements will be reviewed and adhered to in the execution of the agreements with guidance from the legal, privacy, and information technology business units.

RELEVANT CONSULTATION

Consultation has taken place with Legal, Privacy, Risk Management, and Information Technology who have provided input into this report. In addition, consultation was completed with community partners representing a variety of sectors during a Community Partner Workshop, with members of the Situation Table Working Group, Situation Table participants and the Ministry of the Solicitor General.

ANALYSIS AND RATIONALE FOR RECOMMENDATION

The development of a Situation Table and the collection of information without direct identifiers will provide data to assist with informing the Community Safety and Well-Being priorities, support the development of policies and initiatives to address challenges of safety and well-being in our community and provide the provincial government with data to inform future funding to support Community Safety and Well-Being initiatives that will enhance public safety and well-being for all residents in Hamilton. The Situation Table will provide an opportunity to respond to several of the key priority areas identified in Hamilton's Community Safety and Well-Being Plan with the focus on risk intervention and prevention. Should the Collaboration and Information Sharing agreement not be endorsed the Situation Table will not move forward and the benefits for working in this collaborative model will not be realized.

Queen Victoria Elementary School Nutrition Program (Ward 2)

WHEREAS, in 2023 funds from the Ward 2 Non-Property Tax Revenue Account (3301609602) were allocated to organizations that address poverty and food insecurity, including Compass Community Health, 541 Eatery & Exchange, and Helping Hands Street Mission;

WHEREAS, the Queen Victoria Elementary School Nutrition Program is a breakfast program run by the Hamilton Foundation for Student Success for students at Queen Victoria Elementary School in Ward 2;

WHEREAS, nearly 10% of children at Queen Victoria Elementary School experience food insecurity and receive food packages from Food4Kids Hamilton;

WHEREAS, the Queen Victoria Elementary School Nutrition Program received some support through Tastebuds Hamilton, Hamilton Bulldogs, PC Children's Charity, Oakrun Farm Bakery, and other donors;

WHEREAS, the program costs \$1.00 per student for 580 students for 194 school days for a total of \$112,520.00 per school year;

WHEREAS, the Queen Victoria Elementary School Nutrition Program is trying to grow the program so that every child can be offered a meal without singling out those who need it more than others; and

WHEREAS, they are building a pool of volunteers to increase fundraising efforts, but need time to do so, and the need is imminent, with a \$6,000 shortfall in the 2023-24 school year

THEREFORE, BE IT RESOLVED

- (a) That up to \$6,000 be allocated from the Ward 2 Non-Property Tax Revenue Account (3301609602) to the Hamilton Foundation for Student Success; and
- (b) That the Mayor and City Clerk be authorized and directed to execute any required agreement(s) and ancillary documents, with such terms and conditions in a form satisfactory to the City Solicitor.
